Additional Information:

1. All horses must have a negative Coggins to be on show grounds. This applies for companion horses also.
2. All riders under 18 must wear protective ASTM/SEI approved head gear. It is recommended that riders over 18 wear headgear that is safe and discipline appropriate.
3. Windswept Acres LLC, employees, etc. **WILL NOT BE HELD RESPONSIBLE** for any damage, injury, or loss to persons, horse/pony or property of exhibitor or spectator incurred on or off the show grounds. It shall be a condition of entrance to the grounds that this is agreed.
4. Windswept Acres reserves the right to cancel, combine or otherwise alter classes as entries dictates.
5. Show management reserves the right to excuse any horse that is visibly unsound or in ill health, as well as any rider who demonstrates unsportsmanlike behavior.
6. No martingales in under saddle classes.
7. Schooling in ring available 7:30 AM-8:15 AM and at certain points throughout the show schedule. Schooling breaks are ten minutes only; there will be a warm up ring available.
8. Refreshments will be available on the grounds.
9. All dogs must be leashed.
10. Six ribbons will be awarded in each class; Champion and Reserve ribbons in each division.
11. Fence heights are approximate.
12. The decision of the judge is final.
13. There will be a \$15 schooling fee for all horses not registered in a class.
14. Entrants in the leadline division (Classes 1 & 2) may only enter Mini-Short Stirrup classes in order to be eligible for leadline.
